<b>Activity Description</b>	Training and qualifying drivers who have a driving license, with the aim of enabling and providing them with the necessary skills, to drive vehicles intended for professional use, such as taxis, heavy and light buses intended for transporting passengers, heavy vehicles intended for transporting goods, construction vehicles used in work sites, and trailer trucks. It is practiced as an additional activity within licensed vehicle driving facilities <b>only</b> .

<b>Conditions and Procedures of Issuing the Permit</b>	<ol style="list-style-type: none"> <li>1. The applicant shall be one of the driving facilities licensed in the Emirate.</li> <li>2. Obtain the initial approval to practice the activity, which is issued by the Roads and Transport Authority.</li> <li>3. Obtain the approval of the concerned government authorities to carry out the activity in the Emirate.</li> <li>4. Obtain special approvals from government agencies concerned with professional permits in the event that such agencies provide rehabilitation services for a specific type of professional driving, such as permits for taxi drivers, limousine vehicles, public and private transport bus drivers, school buses, and tour buses.</li> <li>5. Pay the prescribed fees</li> </ol>		
<b>Licensing Conditions and Entity's Obligations</b>	<ol style="list-style-type: none"> <li>1. Provide a suitable environment for carrying out the training at the establishment's headquarters, in terms of the availability of a lecture hall equipped with modern presentation tools, and commensurate with the number of trainees.</li> <li>2. Prepare a training curriculum for advanced driving.</li> <li>3. Any other detailed requirements required by RTA or other concerned authorities.</li> </ol>
