	1.	Buses must comply with Gulf specifications and be periodically maintained by the company, and it's fitting	
		to operate must be ensured, while keeping records to show them to the authority official upon inspection.	
	2.	The operational life of the bus must not exceed five years or 1,300,000 kilometers (coach buses,	
		European Bus Classification No. 3).	
	3.	Buses must be inspected and maintained according to requirements specified by the bus manufacturer.	
	4.	The bus must be equipped with all controls to mitigate the dangers of bus fires, including a fire	
		extinguisher system (according to the bus size).	
	5.	The authorized person must provide a camera surveillance system inside the bus, as the bus must be	
		equipped with systems that enable authorized person to monitor of the bus, the driver, the driver's

	7.	The authorized person must ensure the validity of the bus and its main aspects, including but not limited	
		to the tires, at all times and before each trip.	
	8.	The permitted weight of luggage must be adhered to according to the manufacturer's specifications for	
		each bus.	
	9.	A reflective triangle must be provided on the bus.	
	10.	The authorized person must have a manual lever and wheel wrench.	
	11.	Quick fixing tools must be provided.	
	12.	The authorized person must provide internal overhead shelves in the buses and a luggage storage	
		warehouse with sufficient space to contain passengers' luggage on buses.	
	1.	The authorized person must raise drivers' awareness and ensure that they are familiar with safe driving,	
		the locations of tunnels, barriers, bridges, and crossing intersections, the locations, types, and meanings of	
		warning signs, and must provide them with training on these signs, and other things that the bus driver is	
		required to pay attention to and be careful about when driving passenger buses inside and outside the

Requirements.	2.	The authorized person must furnish drivers and ensure their awareness of the laws of the states to be	
		entered to guarantee the compliance with laws related to traffic security and safety.	
	3.	The performance of drivers must be followed on, and in the case of non-compliance or low performance,	
		drivers must be trained by one of the training institutes approved by the RTA.	





	4. An alternative driver must be provided for international lines' trips, while the driving hours for one drive		
	must not exceed 4 consecutive hours, and a maximum of ten hours per shift. Automated syste	ms are to	
	be in place to enable the smart monitoring of the driver while driving the bus.		
	It must be ensured that the driver physical and medical fitness is healthy, free of communicabl	e diseases,	
	and that the license and other required documents on an annual basis are valid.		
	Adherence to the lane designated for buses on the roads and avoidance of driving on the far le	ft lanes on	
	the roads must be ensured.		
	The authorized person must provide comprehensive insurance for buses, which covers liability	towards	
	third parties, the driver, passengers, and all natural risks, and must be valid during the period c	of operation.	
	Contact information with the company, drivers, and trip times must be provided to enable cont	tacting in	
	emergency cases for each trip.		
	A number that can be contacted in case of complaints must be provided.		
General	The shoulder of the road must not be stopped at and a safe stop in emergency cases must be	ensured.	
<b>Requirements and</b>	The necessary permits must be obtained from the competent authority in the state.		
Specifications	Posters containing passenger safety instructions must be provided.		
	A copy of the bus and driver permit must be available at all times.		
	In the case of any traffic accident occurring within the borders of the Emirate of Dubai, the au	thorized	
	person must immediately notify the RTA.		
	In the case of any violations or dangerous behaviors committed by drivers within the borders o	of the	
	Emirate of Dubai, the company must notify the concerned parties in the RTA.
